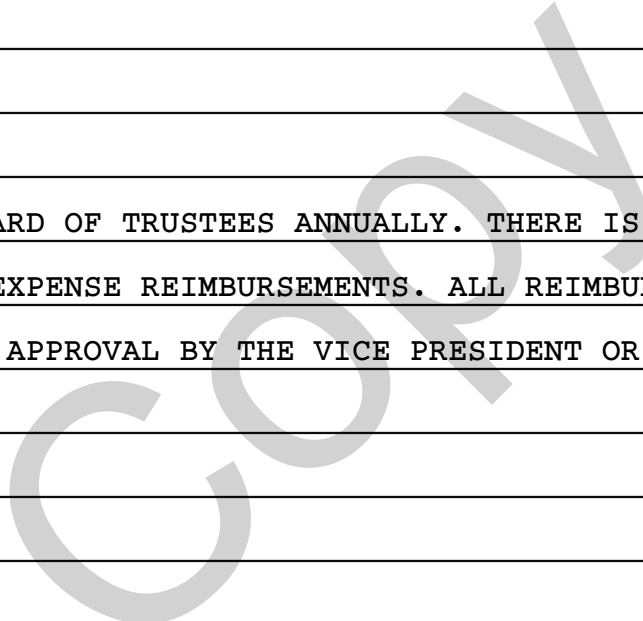

DURING THE YEAR ENDED SEPTEMBER 30, 2011 THE ORGANIZATION COMPLETED A \$10 MILLION TRANSACTION (THE "TRANSACTION") UNDER THE FLORIDA NEW MARKETS DEVELOPMENT PROGRAM (THE "PROGRAM") WITH STONEHENGE COMMUNITY DEVELOPMENT, LLC AND ITS AFFILIATES ("STONEHENGE").
